Sheraton New York Times Square

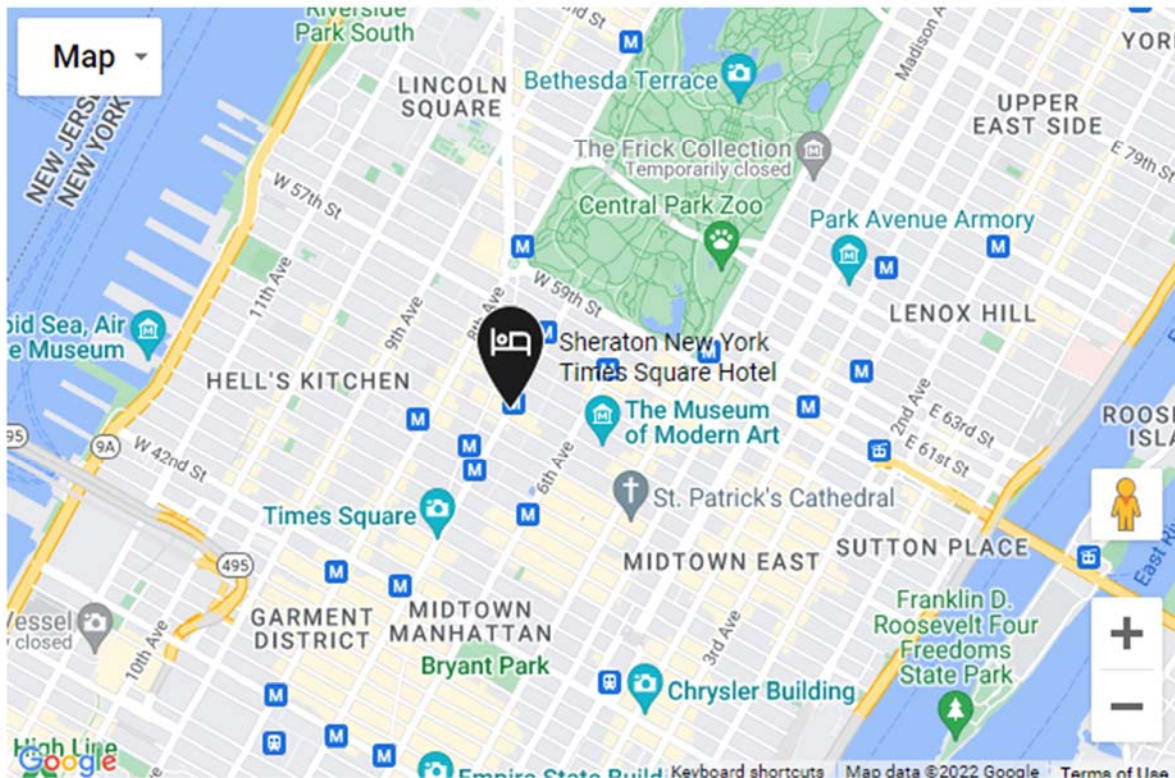
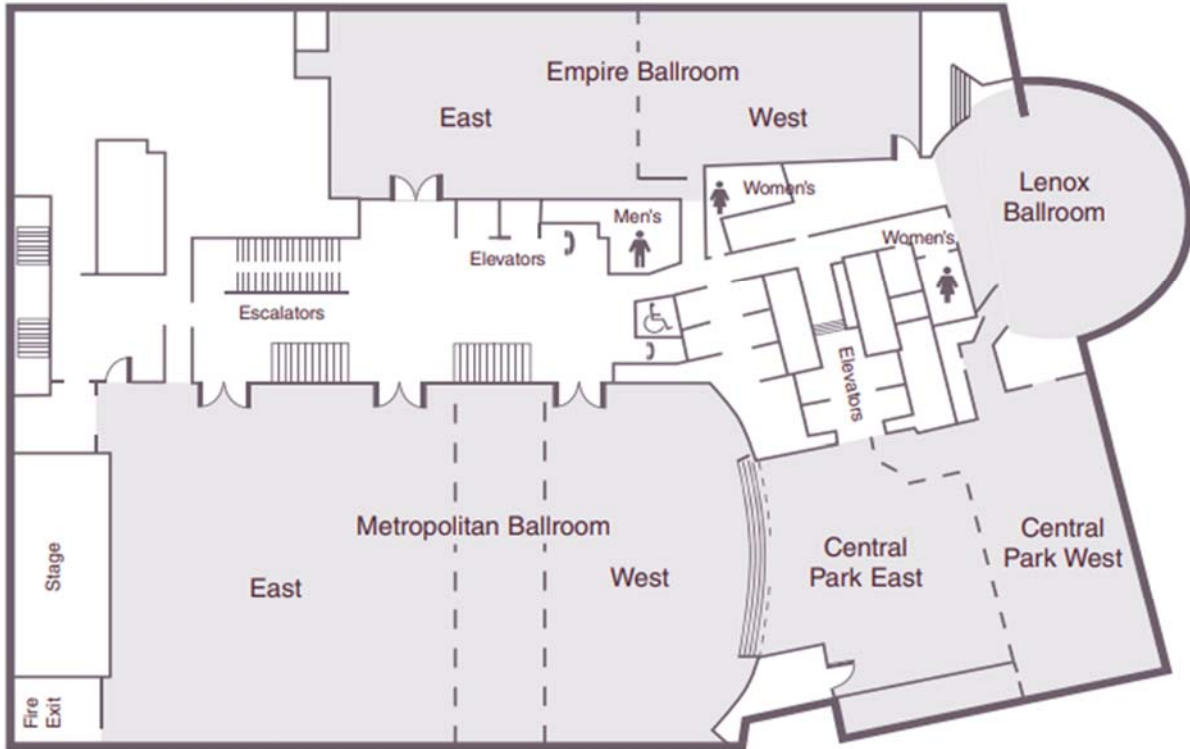

TERMS & CONDITIONS

TERMS OF REFERENCE

In these terms and conditions for exhibiting, the term “Exhibitor” shall include all employees, partnership, firm or individual to whom space has been allocated for the purpose of exhibition. The term “Organizer” shall mean “ISTA 2023 Local Organizing Committee.” The term “Exhibition” shall mean “The 34th Annual Congress of the International Society for Technology in Arthroplasty.”

BOOTH ALLOCATION

The Organizer shall allocate the space in accordance with the nature of the exhibit or in the manner the Organizer deems fit. The Organizer shall reserve the right to change the space allocated to the Exhibitor at any time prior to the commencement of the build-up of the exhibition should the circumstances require changes. Such changes shall be at the discretion of the Organizer. The Exhibitor shall not claim for compensation as a result of the changes.

APPLICATION AND PAYMENT PROCEDURES

Applications should be sent to Organizer along with payment. All payments must be made prior to the Congress.

ACCREDITATION

Current Concepts Institute (CCI) is accredited by the Accreditation Council for Continuing Medical Education (ACCME) to provide continuing medical education for physicians.

This activity has been approved for *AMA PRA Category 1 Credit™*.

Exhibitor agrees to abide by ACCME Standards for Integrity and Independence in Accredited Continuing Education, Standard 5: Manage Ancillary Activities Offered in Conjunction with Accredited Continuing Education, as stated at www.accme.org/standards.

All Commercial Support associated with this activity will be given with the full acknowledgement of CCI and Organizer. No other payment shall be given to CCI, the Organizer, activity director, planning committee members, presenters, or authors, or any others involved with the supported activity.

CANCELLATION

Cancellation will only be accepted under unavoidable circumstances. In the case of changing exhibits or canceling the exhibition, exhibitors should inform the Organizer in writing. Charge for cancellation received prior to April 30, 2023 is 50% of total participation fee. And refunds for cancellation received after May 1, 2023 will not be accepted.

INSTALLATION AND REMOVAL

The installation and removal of the exhibits and booths must be completed by the date and time designated by the Organizer. Exhibitors shall indemnify the Organizer against any loss which may be caused by delay or damage to the Hotel caused by the exhibitor or their agents.

INSURANCE, SECURITY AND SAFETY

Exhibitors are required to subscribe to all risks insurance policy on all equipment and products during the Exhibition as well as during set-up and take-down. The Organizer shall not be held responsible for any loss, theft, or damage to any articles belonging to the Exhibitor.

Exhibitors are liable for any damage caused by their representatives. Materials used in stand and display construction must be properly fireproof in accordance with the local fire and safety regulations. The Organizer shall reserve the right to limit any constructions or demonstrations that pose as potential safety hazards.

USE OF EXHIBIT SPACE

Exhibitors are bound to exhibit the announced products and to man the stands with competent personnel during the open hours of the Exhibition. Activities of the Exhibitor shall be confined within limits of the Exhibitor’s booth. The exhibit will be consistent with the theme of the exhibition and the Organizer reserves the right to restrict.

RESTRICTION ON SELLING

It is agreed that the sole purpose for contracting exhibit space to display and/or demonstrate equipment, supplies and/or services. Cash sales within the confines of the exhibit space are prohibited.

LIABILITY

It is mutually agreed that the Organizer shall not be liable to the Exhibitors for any damage to and/or loss of the Exhibitor’s property, or for injuries to persons resulting from any cause. All claims for any such loss, damage, or injury, are expressly waived by the Exhibitors.

BREACH OF CONTRACT AND WITHDRAWAL BY EXHIBITOR

In the event that the Exhibitor refuses to use all or part of the space allocated or the Exhibitor defaults on the payment, the Organizer shall have the right to terminate the contract forth with. In addition, the stand charges shall not be refunded. If the Exhibitor withdraws from participation without the Organizer’s approval, the already paid money by the Exhibitor shall not be refunded.

CHANGES

The Organizer reserves the right to change the venue and duration of the Exhibition if exceptional circumstances demand such changes. In the event of a change of venue and/or date, or cancellation of the Exhibition, the Exhibitor shall not be entitled to any claim for compensation in connection with the booking for participation.

SUPPLEMENTARY

When necessary, the Organizer shall have the right to issue supplementary regulations in addition to those in the TERMS AND CONDITIONS. Those regulations and instructions shall be binding on the Exhibitors.

ARBITRATION OF DISPUTES

In the event any dispute, difference, or question shall arise between the parties to these TERMS AND CONDITIONS, it is hereby agreed that it shall be resolved through arbitration.
